Subject: Support confirmation of Drs. R. F. Kennedy, Jr., Makary, and Bhattacharya

I am a scientist known in scientific societies for my independence, integrity, and the highest moral standards. On behalf of my 5 children, people of the U.S., and future generations of American children and parents, I am asking you to support the confirmation of Dr. Robert F. Kennedy, Jr. as Secretary of the Department of Health and Human Services (DHHS), Dr. Martin Makary as FDA Commissioner, and Dr. Jay Bhattacharya as Director of the NIH. I am asking you to ignore the pressure of currently ruling elites; they are driven by their conflict of interests and are responsible for the deep crisis of U.S. healthcare.

President-elect Trump has received massive mandate from American people to rectify the crisis. I believe that Drs. Kennedy, Makary, and Bhattacharya are his excellent choice for the leadership to make America healthy again. The triad enjoys the greatest public trust built by their scientific publications, transparency and integrity of social position shown in their books, research papers, and The Great Barrington Declaration.

Current U.S. establishment, which is responsible for gigantic losses caused by COVID-19 pandemic, will certainly resist. I am closely familiar with the state in my area of molecular diagnostics. By 2014 our team of scientists and engineers in TIRF Labs (www.tirf-labs.com) has developed i-Diagnostics (www.i-diagnostics.net) and TIRF Analytix platforms that could prevent COVID-19 pandemic and minimize damages from existing diseases. However, corruption in the NIH, FDA, and CDC and suppression of free speech deprived Americans from precision diagnostics for home-use and from efficient inexpensive treatments.
