OBJECTIONS AND PROTESTS AGAINST ANTI-AMERICAN PRO-CRIMINAL MEMORANDUM & RECOMMENDATION – [DE#78] AND [DE##13-19,27,28,35-38], THAT DISREGARD RESULTS OF FBI INVESTIGATION AND RULINGS OF HONORABLE AMERICAN JUDGES OF INTEGRITY, INCLUDING JUDGES DUNSTON, DAVIDIAN, LINARDY, AND MEYER.

PROTEST AGAINST ANTI-AMERICAN CRIMES COMMITTED BY CORRUPT JUDGES BELL AND RATLEDGE, COYOTE LAWYERS PLEKAN, SUKEENA, AND RICHARDSON, AND ILLEGAL-ALIENS, RECIDIVISTS-MURDERERS KRAVETS AND PETROVA-ASANOV

Plaintiff, Dr. Alexander Asanov, (Dr. Asanov) on behalf of The People of the USA, other Plaintiffs and himself, files objections against pro-criminal, anti-American fraudulent, deceitful Memorandum & Recommendation - Document 78 [DE 78] and expresses his hottest protests against the existential anti-American crimes that imposed existential risks of death and injuries onto hundreds millions of Americans. The memo [78] represents a textbook example of a shameful, systematic corruption, which fatally sickened by cancer the North Carolina state judiciary and has metastasized into U.S. Federal courts.

At the very first line and the very first words of the pro-criminal [DE 78], it becomes crystal-clear evident that the pro-criminal Memo [DE 78] has been cooked under the conflict of financial interests. The author of the memo, Magistrate Judge Swank is driven by her financial interest common with coyote-lawyers, corrupt judges and illegal-aliens, on which her personal income depends.

Indeed, there are tens thousands of corrupt judges in the U.S., hundreds thousands of coyote-lawyers, who are responsible for creating the pool of ~28 millions of illegal-aliens, which drives \$380 Billion criminal industry. This massive criminal industry "feeds" gigantic mass of crimes. It is shockingly surprising that massive bad statistics and the common knowledge facts about the army of coyote lawyers and corrupt judges, Magistrate Judge Swank has not ruled against ANY of coyote lawyer, has not ruled against ANY of corrupt judge, despite the common knowledge fact that by 2024 these criminal cohorts have committed tens millions of felony crimes. Not surprisingly, two of them, Defendant-criminal Sukeena and Defendant-criminal Ratledge, cynically clamed [to Nicolas Asanov] that they have all NC state and Federal judges in their pockets.

This fact is a common knowledge in the over-produced lawyer's community. Indeed, the 8-fold excess of lawyers results in the paradoxical situation: Coyote-lawyers who produce neither goods, nor service, but only troubles an and disasters, who are responsible for destroying the institute of family in the USA, who are personally responsible for mutilation for life millions of American children, are interested in creating more and

more sinecure jobs for their kids. It is not possible without corruption and criminal industry in larges scales. hus, the spiral of cliodynamic cycle is leading to violent riots or civil wars.

We, The People of USA, gave massive mandate to President Trump to resolve this crisis by peaceful reforms. The reforms must include peaceful, non-violent cleansing of the US judiciary, including NC judiciary, from corrupt anti-American traitors. Corrupt judges Bell and Ratledge are two of them. Coyote lawyers Plekan, Sukeena, Richardson – are three of the army. Without their crimes, the illegal-aliens, recidivist-murderers Olena Kravets and Olga Petrova-Asanov would not dare to invade into this country illegally, and certainly would not dare to commit their numerous crimes of attempted-murders, plundering \$400,000, physical injuring of Dr. Asanov, destroying his high-tech business, devastating the unique CBRNE facility TIRF Labs, which was of paramount importance for the entire US nation. Without criminal conspiracy in the gang of criminals, which was documented by the FBI agent Maurer, it would not be possible that the criminals led by anti-American traitor Ratledge, would dare to steal, to plunder, to loot \$400,000 from Dr. Asanov personal assets, which Dr. Asanov acquired after his marriage with Defendant-criminal Kravets. Shockingly, at the same time when the criminals claimed to plunder assets acquired AFTER the marriage, the same crooked criminals did not want to split the \$97,700 debt, which Dr. Asanov acquired in 2020 as the direct result of the attempted-murder and other violent crimes committed by Kravest-Pleakn. Shockingly that FBI agent Maurer stated that the criminal collusion between corrupt judges in NC courts is overwhelmingly stronger than the authority of NC Judges of Integrity, including Judges Dunston, Davidian, Meyer, and Linardy.

Thus it becomes obvious that the pro-criminal [DE 78], the first line points out to "Pro Se" status is translated from crooked language of corrupt judges into plain English, which means that this civil action is brought to the closed club of corrupt judiciary by an unwanted, unwelcomed stranger, who does not belong to the closed club of coyote lawyers and corrupt judges, and who has not paid an fee for a commercial lawyer to play at least formally at the same crooked field under crooked rules that the arbiter will bend ALWAYS in favor of colleagues coyote lawyers and corrupt judges, even if the bent brakes the stone wall of the USA Constitution.

HEREBY, Dr. Asanov refer to Honorable John Fitzgerald Molloy, a lawyer and judge for half a century, who profited from U.S. legal system and seen how it has been degraded in favor of coyote lawyers and corrupt judges. John Molloy testified about the conflict of financial interests in situations similar to Case No. 5:24-CV-82-M-KS. Because Magistrate Judge Swank rules about crimes and misconduct of her dear comrades criminal colleagues, on whom she depends financially, this conflict of interests precludes her from fair and just ruling. Before Chief District Judge Myers, who will also operate under similar conflict of interests, rubber-stamps her pro-criminal biased "findings" and pro-criminal memo [DE#78], Dr. Asanov addresses his EMERGENCY PETITION to President Trump, and incoming U.S. Attorney General Bondi, FBI Director Patel, Border Czar Homan.

On November 5, 2024, We, The People of the USA, gave you the overwhelming mandate to cleanse this country from banana-republic corruption, to deport illegal-aliens, to secure our borders, to restore the rule of law at American soil, to MAGA and MAHA. By my Emergency Petition I am urging you to protect all Americans and my family from the **EXISTENTIAL** risks of death and injuries imposed by the organized criminal group of Defendants-criminals, listed in this civil action 5:24-CV-82-M-KS. This group of Defendants-criminals includes illegal-aliens, recidivist-murderers, coyote lawyers corrupt judges, and crooked corrupt administrators of public schools. As in a droplet of water the ocean of challenging U.S. problems has reflected and refracted in my case 5:24-CV-82-M-KS.

I am a scientists, a unique one with unique skills, unique products and unique technologies that are critically important to U.S. National CBRNE Security. I would be the most efficient and useful for this country, if I will be working 100% at my high-tech facility TIRF Labs for CBRNE security to MAHA. This case 5:24-CV-82-M-KS highlights a text-book example, where an illegal-alien, recidivist-murderer, Kravets, who was a patient of mental institution in her native Ukraine, murdered her husband in Ukraine to seize his property, illegally invaded into the U.S., conspired with U.S. domestic criminals and committed EXISTENTIAL anti-American crimes that imposed the risks of death and injuries onto hundreds millions of Americans. On April 30, 2020, the illegal-alien Kravets attempted to murder me to seize my property in its entirety. After her attempt to murder failed and I survived, she conspired with domestic criminals to plunder ~ \$400, 000 of my personal, out-of-marriage property, which I acquired after our divorce. The illegal-alien Kravets plundered from me \$400,000 in collusion with coyote-lawyers Plekan, Sukeena, Richardson and corrupt judges anti-American traitors Bell and Ratledge. There is overwhelming body of evidence, which shows crystal-clear facts that all Defendants-criminals knowingly and willingly committed their crimes of RICO, Kids-For-Cash attempted-murder, plundering, Stalin-Beria fabrications. They clearly knew that they are committing crimes that will CAUSE EXISTENTIAL DAMAGE TO THE USA NATION and will impose imminent risks of death and injuries onto hundreds millions of Americans. I am urging you to deport the recidivist-murderer, illegal-alien Ms. Olena Kravets without delay. She is suffering from severe mental illness and is extremely dangerous to society. I am urging you to imprison coyote-lawyers Plekan, Sukeena, Richardson, and corrupt judges anti-American traitors Bell and Ratledge without delay. They are dangerous to society, including their own families.

The FBI files, Wake county court documents, my files and testimonies, my children and thousands of similarly situated victims and witnesses have accumulated overwhelming body of evidence about the extremely broad corruption in NC state legal system, which serves to the illegal-aliens, recidivist-murderers, and throws law into dirt.

Numerous RICO, Kids-for-Cash, attempted-murders, and other crimes were committed by illegal-aliens in conspiracy with coyote lawyers and corrupted NC judiciary under the color of "justice". There are terminal cancer tumors of white-collar crimes committed by corrupt judges and coyote lawyers under the color of justice.

I sincerely appreciate fair ruling made by several Honorable Judges of Integrity, including Judges Dunston, Davidian, Meyer, and Linardy. Unlike corrupted judges, who conspire with each other and coyote lawyers to enrich themselves by criminal ways, Honorable Judges of Integrity are truly Independent. Corrupted judges ignore fair and just ruling of Judges of Integrity, but demonstrate remarkable criminal solidarity with other corrupted judges. As the result there is overwhelmingly massive banana-republic corruption in NC state judiciary. Memo [DE 78], against which I hotly protest, provides a text-book example of such cancer tumor corruption.

On Jan 15, 2025, the incoming Honorable U.S. Attorney General, Pamela Bondi, stated at the Senate confirmation hearing: "... two-thirds of Americans have lost faith in the Department of Justice, and ...I believe, .... people continue to lose faith." I guess, Honorable AG Bondi under-estimated. My data show that ~90% do not trust American judicial system anymore.

In 2024 the cancer tumor of judicial corruption has become obvious to the entire world. ~90% of world's population does not trust American "justice" anymore. Americans and the entire world observe day-by-day how U.S. "justice" serves to enforce crimes and to murder righteous U.S. citizens who dare to protest, to turn this beautiful country into a garbage can of a banana-republic.

Multiple assassination attempts against The President Trump, the best popular President ever, the abuse of lawfare to murder and to injure President Trump, is just a top of the iceberg.

Certainly, I am a much smaller figure. But during SIX (6) long years I am the victim of attempts to murder me and systematic abuse by the NC-state lawfare to murder me, to injure my family and me, to plunder my personal property, and to damage my work for U.S. National CBRNE Security.

Despite the overwhelming body of evidence about the crimes committed by Defendants-criminals against me and against the entire U.S., despite crystal-clear federal jurisdiction over the case evident even for a child, despite extremely obnoxious disrespect of Defendants-criminals towards the basic principles of justice, despite the overwhelming body of evidence accumulated in the FBI, Wake county, despite the CBRNE expert opinions, despite mental health evaluation results, despite overwhelming evidence on files and testimonies, Magistrate Judge Swank, operating under her conflict of interests, failed to recuse herself and willingly and knowingly chose to cover the existential anti-American crimes committed by her comrades – coyote lawyers, corrupt judges, illegal-aliens and their criminal gang, the existential crimes against the entire American nation, including herself.

In my original complaint [DE 1], document [DE 42] and other documents I explicitly pointed out to crystal-clear evidence for Federal jurisdiction and respective U.S. code titles related to the civil aspects of RICO, Kids-for-Cash, attempted murder, existential anti-American crimes. [DE 78], however, plays fools by abusing crooked coyote-lawyers criminal argumentation, exploits Tunnel vision corruption, Blind-eye corruption. The criminals falsely claim that their crimes allegedly do not belong to U.S. Federal jurisdiction. Additionally, [DE 78] abused crooked coyote-lawyers language to make pro-criminal argument that Plaintiff allegedly "failed to state a claim..." My original complaint and numerous other submitted documents clearly stated numerous claims and pointed out specific U.S. Code Titles upon that the relief from attempted-murder, RICO, Kids-for-Cash, other crimes must be granted. The Memo [DE#78] would not be possible without prior arrangements between Magistrate judge Swank and District Chief Judge Myers.

By the end of 2024, U.S. judiciary system came to the point, where it serves to criminals. 28 millions of illegal aliens drive \$380B criminal industry, to which the corrupt cohort of judges and coyote lawyers serves to enrich themselves by criminal ways.

Remarkably, despite the fact that a large army of coyote lawyers and corrupt judges serve to 28 million of illegal aliens and their \$380 Billion criminal industry, there is NO ONE SINGLE CASE, in which Magistrate Judge Swank ruled against crimes and misconducts of coyote-lawyers and corrupt judges.

Dear President Trump, this is one of the most important jobs to be done: cleanse the U.S. judiciary the entire legal system from corrupt criminals. It is one of the most challenging and most important jobs to be done.

I, the Plaintiff, Dr. Asanov, hotly and strongly protest against pro-criminal Memorandum [DE 78]. I, the Plaintiff, submit my protest against the pro-criminal memo [DE 78].

In my Emergency Petition to President Trump and his team under perjury of penalty I declare that the information provided below in my Petition is true and correct to the best of my knowledge. My colleagues from scientific societies, Kiwanis and Rotary civic clubs, and local communities state that I am a person with the highest moral standards.

- 1. I, Dr. Alexander Asanov, am a scientist, an internationally recognized expert in the area of CBRNE security with broad background in physics and life sciences.
- 2. I am passionately fighting against corruption in my field of sciences. My colleagues and I will assist you, Dear President Trump, in cleansing from corruption the DHHS, NIH, FDA, CDC and EPA. Honest and independent scientists and administrators will prevail.
  - 3. My advanced platform technologies TIRF Analytix and iDiagnostics are super-innovative, cost-

efficient and capable of preventing new pandemics.

- My products will enable the entire healthcare community with efficient tools for minimizing the damages from existing diseases and for rejuvenating humans to MAGA and MAHA.
- I respectfully petition you to protect my family and me from the recidivist-murderers, illegalaliens, Defendants-criminals, coyote-lawyers and corrupt judges.
- Protection by law and law enforcement agencies will enable my enthusiastic work for the great goals of MAGA and MAHA.
- 7. I am uniquely positioned in the area of CBRNE security and in the field of life sciences. I am capable of working efficiently for preventing future pandemics and minimizing the damages from existing diseases.
- 8. Murdering me will impose existential risks of death and injuries onto hundreds millions of Americans.
- 9. I petition you to finish FBI investigation, which was started by FBI agent Maurer. I am sincerely grateful for his help of stopping a portion of RICO and Kids-for-Cash crimes against me and my family.
- Before his cancer surgery, agent Maurer warned me that the same criminal gang of Defendantscriminals, which attempted to murder me to seize my property, contemplates to abuse NC lawfare to plunder  $\sim$ \$400,000 of my personal assets that I acquired after my marriage with Ms. Kravets. NC family law dictates that only assets and debts acquired during the marriage are subject to 50:50 split. The criminals did not want to split the debt, but committed crimes of plundering my post-marital assets ~\$400,000. They committed very bad crime.
- 11. I married Ms. Kravets in 2012 and did not suspect that she immigrated illegally. Only in April 2020 I realized that she committed a crime to invade into the U.S.. Only in October 2020, six months after she attempted to murder me, I realized that Ms. Kravets murdered her second husband, Mr. Volodimir Kravets, to seize his property. I received that news in October 2020, when I visited Kryvoy Rog, Ukraine. Witnesses in Ukraine showed that Ms. Kravets suffered from traumatic brain injury after a motorcycle accident and was patient of a psychiatric hospital.
- On May 30, 2020 or about, Defendant Kravets, after her April-May 2020 attempts to murder me failed, and after her attempts to seize my residence failed, on her own initiative, upon criminal collusion with illegal-alien Defendant Olga Petrova-Asanov, coyote lawyers Sukeena and Plekan, moved out and established her own household at 224 Terrastone Pl, Cary NC 27519.
- It was a series of extremely sadistic animal-like crimes committed by the coyote-lawyer Plekan, corrupt judges Bell and Ratledge to seize my residence, to throw to the streets my new family with two minor children, to destroy my unique CBRNE security laboratory ~ \$60M value, to impose the risks of death and injuries onto hundreds millions of Americans. THIS WAS EXTREMELY BAD "An evil man will burn EXISTENTIAL CRIME.

- 14. I am urging you to arrest and imprison the extremely vicious Defendants-criminals. They are extremely dangerous to society, including their own families: "An evil man will burn his own nation to the ground to rule over the ashes."
- 15. Sun Tzu wrote this about Defendants-criminals Plekan, Sukeena, Bell and Ratledge. They burned terminally sick Ms. Kravets to loot on her ashes as a roadkill.

In 2020 Ms. Kravets contracted cancer tumor in her brain and exhibited bursts of sporadic 16. aggression in life-threatening situations. They knowingly and willingly exposed Ms. Kravets to society.

Only in 2022 I realized that Ms. Kravets contracted multiple myeloma cancer with metastases in 17.

her brain. Coyote-lawyer Plekan hid this important info to loot on ashes and to suck blood from the poorly sick illegal-alien.

- 18. In 2019-2020 Ms. Kravets exhibited sudden sporadic bursts of violent aggression. In one accident, I was driving my car over the highway, when Ms. Kravets attacked me, which imposed the risk of death or injuries in a road accident. On several other occasions Ms. Kravets broke into my home office and attacked me from behind, for no reason, out of the blue. After her attacks Ms. Kravets was apologetic and related her bursts of aggression to her hormone cycles. After her attack in March 2020, I scheduled for May 5 her diagnosing at the Medical School of Johns Hopkins University. On April 30, 2020, however, Ms. Kravets committed one more attempt to murder me. I have described these crimes in numerous documents.
  - 19. Ms. Kravets is extremely dangerous to society, and must be isolated without delay.
- 20. I survived several attempts to murder me. My new family with two minor children has been injured and plundered by illegal-alien Ms. Kravets, who conspired with U.S. domestic criminals. I demand compensations for injuries and losses caused by these crimes.
- 21. It was professional duty of the coyote lawyer Plekan to provide medical help and schedule mental health evaluation for Ms. Kravets. Defendant-criminal coyote lawyer Plekan failed to implement her duties. Plekan must be arrested without delay.
- 22. Instead, Defendant-criminal Plekan chose to loot onto Ms. Kravets the poor victim of brain injuries, similar to vulture looting on a roadkill. Defendant-criminal Plekan conspired with corrupt judges Bell and Ratledge to commit RICO, Kids-for-Cash, plundering, murdering and other crimes.
- 23. I estimate that ~90% of Americans have lost the faith to U.S. justice, because of the cancer tumor corruption in American judiciary. Thousands of U.S. judges who broke laws or oaths remained on the bench <a href="https://www.reuters.com/investigates/special-report/usa-judges-misconduct/">https://www.reuters.com/investigates/special-report/usa-judges-misconduct/</a>. However, U.S. mass media even does not dare to inform about the scales of this terrible corruption. The data was reported by UK Reuters. Reuters still has guts to report about cancer tumor corruption in American judiciary.
- 24. In 2024 there is ~8-fold excess of lawyers, which created an army of coyote-lawyers and corrupt judges that produced and are serving to ~26 millions of illegal-aliens. The illegals are driving circa ~\$380 Billion criminal industry, which is transforming this country into a banana republic.
- 25. This civil action brought to light RICO and Kids-For-Cash-NC criminal industry and sues for compensatory damages just two (2) out of 26 millions of illegal-aliens, Defendants Kravets and Olga Petrova-Asanov, as well as several U.S. domestic criminals three coyote-lawyers Plekan, Richardson, and Sukeena and two corrupt judges Bell and Ratledge, with whom the illegal-aliens colluded to commit their crimes, and who under the color of justice committed felony RICO crimes to enrich themselves by criminal ways.
- 26. The 26M/\$360B criminal industry imposes imminent risk of the U.S. collapse, as warned by the entrepreneur Elon Musk [ @elonmusk ], the cliodynamics scientist Dr. Peter Turchin [www.petertuchin.com], attorney Alan Dershowitz [ @AlanDersh ], and numerous other patriotic individuals. On November 5, 2024, we The People of the U.S. gave overwhelming mandate to the President Trump to cleanse this country from banana-republic corruption, to deport 26 millions of illegals who turn America into a criminal nightmare.
- 27. As I mentioned, I am a naturalized U.S. citizen, legal, for-merit immigrant. In 1994, U.S. Government admitted me to immigration in the category of Outstanding Researcher and Professor. Back in Russia I was trained by four Nobel Prize winners: Drs. N. N. Semenov, P. L. Kapitsa A.D. Sakharov, V. L. Ginzburg and dozens of other super-talented scientists. In 1994 I came to the U.S. to save my family from massive organized crimes in Moscow. In 1994 I knew nobody and had nothing but my skills and knowledge in the area of chemical physics and life sciences. By 2001 I have achieved the American dream, assembled a team of super-talented scientists and engineers, developed TIRF Analytix and iDiagnostics platforms for CBRNE security, created ~150 high-tech jobs and contributed into prosperity and security of U.S. nation. I guess that I

am a walking example of the positive role of for-merit legal immigrants in the U.S.

- 28. On the other hand, the stories behind illegal-aliens Ms. Kravets and Ms. Petrova-Asanov are a text-book example of the devastating role of illegal-aliens.
- 29. This case represents a text-book example of the striking contrast between *lawful* and *illegal* immigrants. While I, a lawful for-merit immigrant achieved the American Dream and contributed into prosperity and security of all Americans, the illegal-aliens, recidivists-murderers Defendants Olena Kravets and Olga Petrova-Asanov, who were heavy burdens for their native countries, illegally invaded into the USA and conspired with U.S. domestic criminals, devastated millions of Americans and imposed imminent risks of death and damages onto the entire US nation.
- 30. On behalf of The People of the USA, I submit my protests against pro-criminal Memo & Recommendations [DE 78], fraudulent motions of Defendants-criminals to dismiss, against their deceitful demagogic statements "failure to state a claim," against their foul criminal game of allegedly "non-Federal jurisdiction" on their all-American crimes that damaged millions of Americans, including RICO felonies, against disgraceful "Gatekeeper" injunction, which violates the most fundamental right for freedom of speech, and against their deceitful, EXTREMELY INSOLENT INHUMAN motion for sanctions (sic!) filed with the evident criminal purpose to intimidate their victims. These criminals belong to prison. Without any delay.
- 31. Defendants-criminals abused the criminal gang of corrupt NC judges and disregarded judgements and rulings made by independent NC Judges of Integrity. I have filed my objections and protests against motions and requests fraudulently filed by the Defendants-criminals in the Documents: 13-19, 27, 28, and 35-38.
- 32. On April 30, 2024, I submitted [DE 42] my objections and protests against fraudulent motions of Defendants-criminals to dismiss, against the disgraceful "gatekeeper" and victim-intimidation sanctions [DE 13-19, 27, 28, 35-38]. This documents and exhibits provided crystal-clear evidence that the motions filed by Defendants-criminals are fraudulent. My motions contain references to respective legal codes.
- 33. [DE 78], however, in violation of all judicial standards, failed to take my complaints, submissions, and evidences provided by the FBI and Judges of Integrity.
- 34. Violating all basic principle of justice, Magistrate Judge Swank demonstrated solidarity with Defendants-criminals. She bent the most fundamental rules of this court in favor of criminals.
- 35. Magistrate Judge Swank failed to enter a default judgement against Defendants-criminals Sukeena and Ratledge. Both of them have been served upon with the summons and the complaints.
- 36. Similar to corrupt NC state court, Magistrate Judge Swank attempts to disintegrate this civil action, violating the judicial principle of consolidating cases originating from the same circumstances.
- 37. Dear President Trump, U.S. Attorney General Pamela Bondi, FBI Director Kash Patel, Border Czar Thomas Homan, I am petitioning you on Emergency basis to arrest and deport the illegal-aliens, recidivist-murderers, Kravets and Petrova-Asanov, arrest and imprison coyote-lawyers Plekan, Sukeena, Richardson, and corrupt judges Bell and Ratledge, as well as investigate criminal misconduct of Magistrate Judge Swank.
- 38. <u>Injuries and Damages:</u> Defendants-criminals plundered from me and my current family \$400,000 to enrich themselves by criminal ways and to reward the illegal-aliens, recidivists-murderers Defendants Kravets and Olga Petrova-Asanov for their felony crimes. Their extremely vicious crimes damaging the U.S. National CBRNE Security and imposed imminent risks of death and injuries onto hundreds millions of Americans. As a direct and proximate case of Defendants-criminals crimes and Defendant-FBI negligence, I, Plaintiff, Dr. Asanov, and my family with minor children, were injured and damaged. I survived several attempted-murder attacks. I and my family were injured, abused, assaulted, tormented, violated, harassed, intimidated, and suffered permanent injuries, including but not limited to severe emotional and physical pain and suffering, deteriorated health, post-traumatic stress disorder, insomnia, anxiety, shock, fear, nightmares, shame, embarrassment, loss of enjoyment of life, flashbacks, need for future medical expenses, and other

- 39. I believe that I and other Plaintiffs are entitled to be protected against crimes and are eligible to receive compensations for damages. The pro-criminal [DE 78] denies protection and covers the crimes committed by coyote lawyers and corrupt judges, who currently dominate the NC state courts and overall judiciary.
- 40. The Magistrate Judge Swank belongs to the closed club of lawyers, to which Dr. Asanov is an outsider. Honorable John Fitzgerald Molloy, a lawyer and judge for half a century, who profited from U.S. legal system and seen how it has been degraded in favor of coyote lawyers and corrupt judges, **testified about the conflict of financial interests** in situations similar to Case No. 5:24-CV-82-M-KS. Because Magistrate Judge Swank rules about crimes and misconduct of her dear criminal colleagues, on whom she depends financially, this conflict of interests precludes from fair and just ruling.
- 41. Before Chief District Judge Myers, who will also operate under similar conflict of interests, rubber-stamps the pro-criminal biased "findings" and pro-criminal recommendations of the crooked [DE 78], before Judge Myers tolerates Tunnel Vison and Blind Eye corruption of the surprisingly striking omissions about the anti-American EXISTENTIAL crimes and ignores the evidences about the attempted-murder, existential anti-American crimes submitted by CBRNE experts, before the Chief Judge turns his Blind Eye and focuses his Tunnel-vison out of the EXISTENTIAL anti-American crimes, Dr. Asanov expresses his hottest protests against these anti-American crimes and pro-criminal [DE 78].
- 42. Together with his hottest protests against pro-criminal memo [DE 78], Dr. Asanov files his Emergency Petitions to Protect, to investigate the crimes, and to defend U.S. citizens from the existential crimes. Dr. Asanov addresses his Emergency Petition to the President Donald J. Trump and his incoming team of U.S. Attorney General Pamela Bondi, FBI Director Kash Patel, Border Czar Thomas Homan, and other officers.

### **CONCLUSION AND REQUESTS FOR RELIEF**

Based on the foregoing, I, the Plaintiff, Dr. Asanov, express my hot protests against fraudulent pro-criminal Memorandum and Recommendation [DE 78]. I have overwhelming body of evidence, which shows broad corruption of the North Carolina state judiciary. NC state judiciary is suffering from cancer tumor of banana-republic corruption. Corrupt judges and coyote lawyers are serving the criminals, illegal-aliens, recidivist-murderer, at the expense of damaging the U.S. National CBRNE Security, injuring and intimidating law-abiding citizens.

While the Defendant-FBI failed to investigate, the Defendants-criminals devastated unique high-technology laboratory TIRF Labs, which estimated value exceeds \$60 million, and which was of paramount importance for U.S. National CBRNE Security.
